#### Lower Delaware and Autism Delaware Come Together

Last fall several parents and some Sussex Consortium staff came to Newark to look at POW&R, visiting various job and volunteer sites. They were very excited about what they saw, and invited us to give a presentation in Sussex that several Lower Delaware Autism Foundation (LDAF) staff and board members attended. LDAF has long intended to use their resources to develop services for adults and were eager to learn about

POW&R. What they learned led them to open discussions about a merger

of the two organizations—opening a new chapter of autism services in Delaware and paving the way for adult services in Sussex County.

It's true that Autism Delaware has had a greater presence in New Castle and Kent Counties than Sussex, both because of distance and because Sussex had LDAF. The two organizations have joined forces to advocate on common issues over the past three years, getting to know and trust each other. As the need for adult services emerged, we all recognized that we have a common mission – to improve the lives of individuals with autism. Both organizations also share the constant need to raise money for operations in an increasingly difficult economic landscape; and finally, we both recognize the public confusion over two autism groups.

When looking at these issues, the LDAF board decided to approach Autism Delaware about a possible merger, with the

intent to put their resources into developing POW&R downstate. The Autism Delaware board was very excited about this opportunity for all the reasons above, plus the ability to truly be a statewide organization. The two boards quickly developed the John/Rob negotiating teams and met over the spring. LDAF's representatives were their president, John Willey and attorney Rob Gibbs. Autism Delaware was represented by

president, Rob Gilsdorf, attorney, John Fisher-Gray, and Theda Ellis. Proposals and counter

proposals were made and quickly agreed upon. Key components of the agreement to come together include the following:

- Five board members of LDAF will join the Autism Delaware board, which will increase to 20, then pare back to 15 over the next five years.
- LDAF programs for individuals will remain intact, based on funding availability. This includes the four-day summer camp for children, the summer swim program, and the golf program.
- Two LDAF fundraisers will continue as Autism Delaware fundraisers to support operations, including the Autism Ball and Auction and the Race for Autism. Our plan is to expand the run to coincide with the upstate Walk for Autism.

- Autism Delaware is committed to having POW&R fully operational downstate by summer 2012.
- Melissa Tice Martin, Executive Director of LDAF, joins the Autism Delaware staff. Melissa will become responsible for POW&R in Sussex, and will undergo training in 2010 and 2011 to be fully prepared. She will continue her responsibilities as a local person providing information and referral, remain on some state councils and support the traditional programs of LDAF.
- By June of 2012 Autism Delaware will have a fully staffed office downstate, shared by Melissa, Dafne Carnright, our Downstate Coordinator, and the POW&R staff.



# **Legislative Corner**

Legislative Roundup 2010

\*As of press time, the General Assembly had not closed so more actions may have been taken. Check our website for any updates!\*

Autism insurance reform (SB204): SB204 would require insurance coverage of ABA (up to \$50,000/year) and other standard therapies for autism. The bill's prospects were dimmed by an overestimated cost to the state, so we and Autism Speaks are working with the state to come up with more accurate projections, and smooth the way to passage in 2011! See our website for the actuarial report.

Needs-based funding (HB436): Part of this bill would end the guarantee of specific specialists and ratios in the "special schools" serving kids with disabilities and impose a system of classifying all



special ed students in a district by need to determine how many specialists in general would be allocated to them. Because it would reduce resources and safeguards for DAP, we oppose that and advocate for a way to better serve all children with disabilities without taking away from existing services. The bill is tabled in committee.

Funding for adult services (state budget): We advocated to preserve funding for adult services in the Division of Developmental Disabilities Services for existing clients and to add incoming graduates. At press, day services should be funded, but only seven emergency placements (for when a family can no longer care for their adult child) are funded, though in FY10 over 50 were needed.

Education rights (HB328): Signed into law on June 17, the new law broadens the definition of a "free and appropriate education" to comply with a federal court's ruling on what IDEA requires. Autism Delaware testified in favor of this bill, which passed with no opposing votes.

### **Educational Advocacy**

Autism Delaware receives many calls each month about educational concerns from parents of children with Asperger's Syndrome or high functioning autism; students who are not served by the DAP programs but are on the spectrum. Many parents report concerns about how difficult it seems for the unique needs of their children to be appropriately addressed at school.



Last summer, we received so many parent calls about this that we began an educational advocacy project to address this issue. We contacted parents and experts to draft recommendations to improve the education of these students. We first presented the need for such change to the Governor's Advisory Council for Exceptional Citizens (GACEC) in February of 2010. Then, more recently, we presented recommendations to the Delaware Department of Education, Secretary Lowery and Martha Toomey, who recognized the need to address this issue. We forwarded the specific recommendations to the GACEC, who formed an ad hoc committee to review them and make recommendations from the Council.

Some of our recommendations were:



- A major Department of Education initiative that would include teacher training and certification, in-service opportunities, financial incentives for teachers, technical assistance for school districts, a support materials checklist and increased accountability for schools.
- An expanded pilot program for the Social Thinking initiative, with the goal to have Social Thinking in effect in every school where it is needed.
- Specialized training for teachers, paraprofessionals, educational diagnosticians, counselors, psychologists and principals. These training programs should help professionals identify those with Asperger's and high functioning

autism as well as effectively teach academic skills, social skills and functional life skills.

We will keep you informed on the progress of this advocacy effort. To get involved, please call our office!



# **Downstate Summer Programs and Happenings**

We have many new activities and ventures planned for downstate individuals and families. First, we have partnered with the Milton Historical Society and planned a free Day of Family Fun at the Milton Museum in July. Limited openings are available – please call the Milford office to register.

We also recently formed a partnership with Carmike Cinemas at the Dover Mall. They are going to offer Saturday Sensory Friendly movie events to be scheduled as appropriate movies become available. The first one was held in May and they kept the volume turned down, the lights on low, and it was ok for people to get up and move around if needed. They also allowed our families to bring in a snack from home if they were on a special diet!

Several successful LDAF programs will also continue downstate through the merger of the two organizations.

The Junior Golf Program will be led

by Coach Butch Holtzclaw, Golf Pro at The Rookery. This is the second summer Coach Butch will introduce children and teens with autism ages 8-22 to the great game of golf. This is a family program, which means that a parent or caregiver is also a participant during the evening sessions. Equipment for this program will be provided by The Rookery, purchased through a grant generously provided by The Philadelphia Foundation and The Greater Philadelphia PGA.

Youth with autism ages 2-22 can make a splash during our Summer Swim Camp Program at the Plantations Pool in Lewes on Fridays from 10-11am. Coaches Nancy Berg and Christina Cutts will help develop swimming skills and pool etiquette in a safe, supportive environment.

The Day Camp Program in partnership with the Children's Beach House in August is designed to increase self-confidence, improve peer and social interactions, and encourage campers to discover and pursue their own unique interests and goals. In all activities, we will use a "Challenge by Choice" approach, meaning that we will encourage campers to stretch their limits in trying something new, but will never force them into an activity in which they may not be comfortable.

#### What's a parent to do?

You get that phone call, memo or email that details another change in your child's school program. If you are like me, you start to wonder what's going on and make some calls or send some emails yourself to gather information. Maybe you start to wonder if this change will affect your child or the integrity of the program. Is this issue worth raising your voice and will you be alone in the outcry?

The founding parents of the DAP worked very long and very hard to create a program to suit the needs of children who are growing up while living with autism. Those parents worked with legislators and the school districts to ensure that no child with autism who lives in the state of Delaware will be without a free and appropriate public education. Like the founding fathers of our country, they couldn't foresee the growth and change that would take place as time went on. They also tried to think of all possible scenarios, but as with the Constitution, there is much left for interpretation.

When changes are proposed, we need to ask ourselves about how the change will serve the greater good of the program. If we give a little now and lose this opportunity, what more will be compromised? Will there be a domino effect that has no end?

As parents, we are always our children's best advocates. It is our job to oversee decisions being made on behalf of our children's education and to question those making the decisions. It can be as simple as attending a PAC meeting to voice your concerns or making a phone call to your local legislators asking them to allocate funds where they can do the most good. Pay attention to the legislative alerts sent out by Autism Delaware. Don't assume that someone else will do it – we need to be a united front, a force to reckoned with.


### The Inner Circle
